- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Development Business, issue no. WB1268-06/12 of 6th June 2012.
- 2. The Government of the United Republic of Tanzania has received a Credit from the International Development Association towards the cost of the Productive Social Safety Net Project APL1, and it intends to apply part of the proceeds of this credit to payments under contracts for supply of ICT Supplies, Stationery and motor vehicle spares as indicated in paragraph three below. These contracts will be jointly financed by the Department for International Development (DFID), United States Agency for International Development (USAID), and the Kingdom of Spain. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **The Executive Director, Tanzania Social Action Fund.**
- 7. All bids must be accompanied by a bid securing declaration in the format provided in the bidding documents.
- 8. All bids in one original plus **three copies**, properly filled in, and enclosed in plain envelopes marked with **tender description and number** together with **words "do not open before 10.am on 11th January, 2013"** must be delivered to the address below at or before **10:00 a.m 11th January, 2013**. Bids delivered shall be registered at Room No. 20 on the third floor of TASAF Head quarters main building. Bids will be opened promptly thereafter in public and in the presence of Bidders' representatives who choose to attend in the opening at the TASAF Conference Room No. 35

9. Late bids, portion of bids, electronic bids, bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
